**A RESOLUTION ENACTING AN ORDINANCE ESTABLISHING GUIDELINES
ON THE IMPLEMENTATION OF MODIFIED GENERAL COMMUNITY
QUARANTINE (MGCQ) IN THE MUNICIPALITY OF POLILLO, QUEZON AND
PROVIDING PENALTIES FOR VIOLATIONS THEREOF**

WHEREAS, President Rodrigo Roa Duterte in his Memorandum dated March 16, 2020, imposed an Enhanced Community Quarantine and Stringent Social Distancing Measures over the entire Luzon, including the National Capital Region (NCR), effective 00:00 (12:00 a.m.) of 17 March 2020 expiring on 00:00 (12:00 a.m.) of 13 April 2020;


WHEREAS, the IATF – IED issued Omnibus Guidelines on the implementation of Community Quarantine in the Philippines with amendments as of July 2, 2020;

WHEREAS, the IATF – IED Resolution No. 50-A declared Modified General Community Quarantine (MGCQ) in Quezon Province from July 1, 2020 to July 15, 2020;

WHEREAS, as of July 2, 2020, Polillo has One (1) Confirmed Case, Four (4) Suspect Cases and 434 PUMs;

WHEREAS, there is a need to build on existing response measures of the government relative to the COVID -19 outbreak, maximize the gains we have achieved thus far, and complement efforts to strengthen systems to prevent the spread of the virus, while striking balance between biosafety and economy;

WHEREAS, the COVID – 19 Municipal Inter – Agency Task Force approved the MGCQ guidelines to be implemented in the Municipality to ensure the health and safety of the people, while allowing easing of protocols and resumption of operations of government offices and selected private business establishments;

WHEREAS, measures that will support the goal of the national government of flattening the curve of local transmissions of the virus in the country must be put in place;

NOW, THEREFORE, on motion from the Committee on Rules and Privileges/Ordinances & Legal Matters through its Chairman, Municipal Councilor Albert R. Agunias, be it:

RESOLVED, as it is hereby resolved, to enact An Ordinance Establishing Guidelines on the Implementation of Modified General Community Quarantine (MGCQ) in the Municipality of Polillo, Quezon and providing Penalties for Violations Thereof;

MUNICIPAL ORDINANCE NO.144-2020

AN ORDINANCE ESTABLISHING GUIDELINES ON THE IMPLEMENTATION OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE MUNICIPALITY OF POLILLO, QUEZON AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

Be it ordained by this Honorable Sangguniang Bayan in its regular session assembled that;

SECTION 1. MODIFIED GENERAL COMMUNITY QUARANTINE. The whole Municipality of Polillo shall be placed under **MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ)** starting on July 1, 2020, 00:01 AM until such time that the MGCQ is lifted.

SECTION 2. DEFINITION OF TERMS. For purposes of these Guidelines, the following Terms shall be defined as follows;

1. **Community Quarantine** – restrictions of movement within, into, or out of the area of quarantine on individuals, large groups of people, or communities, designed to reduce the likelihood of transmission of COVID – 19 among persons in and to persons outside the affected area.
2. **COVID – 19** – Coronavirus Disease 2019 which is caused the virus known as the severe acute respiratory syndrome corona virus 2 (SARS – CoV – 2).

3. **Modified General Community Quarantine (MGCQ)** – refers to the transition phase between GCQ and the New Normal, when the following temporary measures are relaxed and become less necessary; limiting movement and transportation, the regulation of operating industries, and the presence of uniformed personnel to enforce community quarantine protocols.
4. **Minimum Public Health Standards** – guidelines set by the Department of Health (DOH), as well as sector relevant guidelines issued by government agencies, to aid all sectors in all settings to implement non – pharmaceutical interventions (NPI), which refer to public health measures that do not involve vaccines, medications or other pharmaceutical interventions, which individuals and communities carry out in order to reduce transmission rates, contact rates, and the duration of the infectiousness of individuals in the population to mitigate COVID – 19.
5. **Essential Goods and Services** – covers health and social services to secure the safety and well -being of persons, such as but not limited to, food, water, medicine, medical devices, public utilities, energy and others as may be determined by MIATF.

SECTION 3. The operation of establishments in the municipality shall be in accordance with the following parameters;

- I. **CATEGORY I.** Industries are allowed at **FULL OPERATIONAL CAPACITY**:
 1. Agriculture, forestry, and fisheries and their workers, including farmers, Agrarian Reform Beneficiaries (ARBs), fisher folks and agri – fishery stores and its entire value chain.
 2. Hospitals, medical clinics, and health clinics such as dermatological and other clinics for non – aesthetic such as dental, optometric, and eye, ear, nose, throat (EENT), subject to strict health standards and strict observance of infection prevention and control protocols. Wearing of PPE by dentists and attendants shall be mandatory.
 3. Retail establishments (groceries, public markets, pharmacies and drug stores).
 4. Laundry shops (including self – service).
 5. Food preparation establishments in so far as take-out and delivery services and water refilling stations.
 6. Logistics service provider (cargo handling, warehousing, trucking, freight forwarding and shipping line).
 7. Delivery services, whether in – house or outsourced, transporting food, medicine, or other essential goods such as hygiene products and medical supplies, clothing and office supplies, including computer accessories, IT, communications and other electronic equipment, pet foods and other veterinary products.
 8. Power, energy, water, information technology and telecommunications supplies and facilities, including waste disposal services, as well as property managements and building utility services.
 9. Electricity, gas, steam and air conditioning supply services.




10. Waste collection, treatment and disposal activities and materials recovery.
11. Sewerage (except emptying of septic tank but including pest control).
12. Repair and installation of machinery and equipment.
13. Telecommunication companies, internet services, cable television providers, including those who perform indirect services such as the technical, sales and other support personnel, as well as the employment of the third party contractors doing sales, installation, maintenance and repair works.
14. Property management and building utility services.
15. Energy companies, their third party contractors and service providers, including employees involve in electric transmission and distribution, electric power plant and line maintenance, electricity market and retail suppliers, as well as those involved in the explorations, operations, trading and delivery of coal, oil, crude or petroleum and by – products.
16. Gasoline stations.
17. Construction works on facilities identified for purposes of quarantine and isolation, including such facilities for the health sector, emergency works, flood control and other disaster risk reduction and rehabilitation works.
18. Manufacturing companies and suppliers of equipment or products necessary to perform construction works.
19. Media establishments.

II. **CATEGORY II**. Industries are allowed at **FULL OPERATIONAL CAPACITY**, which includes the following;

1. Other manufacturing activities:
 1. Beverages (alcoholic drinks)
 2. Electrical machinery
 3. Wood products and furniture
 4. Non – metallic products
 5. Coke and refined petroleum products
 6. Other non – metallic mineral products.
 7. Computer, electronic and optical products
 8. Electrical equipment
 9. Machinery and equipment
 10. Motor vehicles, trailers and semi – trailers.
 11. Other transport equipment.
2. Mining and quarrying
3. Electronic commerce companies
4. Postal and courier and delivery services
5. Real estate activities (including leasing, buying and selling, subdividing, appraising, and development of cemetery and columbarium)
6. Repair of computers and personal and household goods
7. Housing service activities
8. Office administrative, office support and other businesses, such as but not limited to photocopying, billing and record keeping services.
9. Accommodation only for the following:
 - a. Guests who have existing long term bookings
 - b. Distressed OFWs and stranded Filipino or foreign nationals

- c. Repatriated OFWs in compliance with approved quarantine protocols
 - d. Non – OFWs who may be required to undergo mandatory facility – based quarantine
 - e. Health care workers and other employees from exempted establishments.
10. Funeral and embalming services. Provided, that funeral service operators are directed to provide shuttling services and/or housing accommodations for their personnel and staff.
11. All public and private construction projects, but with strict compliance to the issued construction safety guidelines for the implementation of infrastructure projects during the COVID – 19 pandemic.

III. CATEGORY III. Industries are allowed to operate at FULL OPERATIONAL CAPACITY, which include the following;

1. Money transfer services, microfinance institutions, pawnshops and other credit cooperatives, including their armored vehicle services, if any.
2. Legal and accounting services.
3. Architecture and engineering services; Technical testing and analysis.
4. Computer programming (such as writing, modifying, testing and supporting software, planning and designing computer systems), information service activities (such as data processing and hosting activities) and other related activities.
5. Rental and leasing activities, other than real estate (such as leasing of motor vehicles, machinery, except for entertainment and mass gathering purposes).
6. Other activities such as photography services, fashion, industrial graphic and interior design.
7. Barbershops and salon (including nail care), subject to compliance with strict health standards.
8. Other non – leisure wholesale and retail establishments and activities;
 - a. Wholesale and retail trade of motor vehicles, motorcycles and bicycles including their parts and components.
 - b. Repair of motor vehicles, motorcycles and bicycles (including vulcanizing shops, battery repair shops, auto repair shops)
 - c. Hardware stores
 - d. Bookstores and school and office supplies stores
 - e. Baby care supplies stores
 - f. Pet food and pet care supplies
 - g. IT, communications and electronic equipment
 - h. Flower, jewelry, novelty, antique, perfume shops

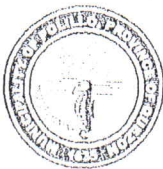
IV. CATEGORY IV Industries allowed at FIFTY PERCENT (50%) OPERATIONAL CAPACITY.

1. Gyms/fitness studios and sports facilities
2. Entertainment industries such as but not limited to cinemas and theaters, karaoke bars, comedy bars, pubs, bars, nightclubs, beerhouses etc.

3. Libraries, archives, museums, and other cultural centers, art galleries, botanical and zoological gardens.
4. Tourist destinations such as but not limited to water parks, beaches and resorts except those used as quarantine facility.
5. Travel agencies, tour operators, reservation services, and related activities.
6. Personal care services such as massage parlors, sauna bath establishments, facial care, foot spa and waxing salon.
7. Internet and computer shops, subject to strict health protocols, but only for work or educational purposes.

V. OTHER PERMITTED ESTABLISHMENTS SUBJECT TO STRICTER GUIDELINES AS FOLLOWS:


1. Barber shops, salons, and other personal care service establishments, at a maximum of fifty percent (50%) of venue capacity subject to observation of DTI Memorandum Circular No. 20-38, Updated Guidelines for Barbershops and Salons pursuant to IATF Resolution No. 51 Series of 2020, Amending for the purpose DTI Memorandum Circular 20-28, Series of 2020;
2. Dine - in restaurants, fast foods and food retail establishments, grocery stores and food preparation establishments, at a maximum of 50% of seating capacity subject to observation to DTI Memorandum Circular No. 20-37, Guidelines on the Implementation of Minimum Health Protocols for Dine-In Services by Restaurants and Fast Food Establishments dated June 22, 2020.
3. Hotel and other accommodation establishments accredited as provided by law and relevant to DOT Memorandum Circular No. 2020-002 Health and Safety Guidelines Governing the Operations of Accommodation Establishments under the New Normal and DILG issuances may operate only upon issuance of a Certificate of Authority to Operate by the MIATF but only up to 50% capacity.


SECTION 4. MOVEMENT OF ALL PERSONS UNDER MGCQ. The movement of all persons in areas placed under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate.

Any person below twenty – one (21) years old, those who are sixty years (60) old and above, those with immunodeficiency, comorbidities, or other health risks, and pregnant women, including any person who resides with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services or for work in permitted industries and offices.

SECTION 5. WEARING OF FACE MASKS IN PUBLIC PLACES AND OBSERVANCE OF PHYSICAL DISTANCING. Wearing of face masks in public places is mandatory. Only persons with face masks shall be allowed to enter hospitals, government or private offices, stores, markets, drugstores, banks, and other establishments which are allowed to operate during the MGCQ.

SECTION 6. CURFEW. Curfew hours shall be from 10:00 in the evening until 4:00 in the morning. Within the curfew hours, no person shall be out of

residence, except in cases of emergency or in going to or from work in exempt sectors and frontline offices.

- 6.1. All government offices, public markets, and authorized establishments must be closed at 10:00 in the evening.

SECTION 7. WORK IN THE MUNICIPAL GOVERNMENT. Work in the municipal government shall be at **FULL OPERATIONAL CAPACITY** with work arrangements for persons who are Sixty (60) years old and above, those with immunodeficiency, comorbidity, or other health risks, and pregnant woman.

At the discretion of the Local Chief Executive (LCE), the LGU may adopt alternative work arrangement and support mechanisms for workers, subject to the guidelines issued by the Civil Service Commission (CSC).

SECTION 8. MASS GATHERINGS. Mass gatherings such as but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to fifty percent (50%) of the seating or venue capacity.

SECTION 9. INDOOR AND OUTDOOR EXERCISES. Outdoor no contact exercises shall be allowed, subject to the minimum public health standards:

1. Indoor and outdoor non – contact sports and other forms of exercise such as but not limited to walking, jogging, running, biking, swimming, tennis, badminton, and skateboarding are allowed.
2. Wearing of face masks shall be mandatory.
3. Physical distancing shall be observed.
4. No sharing of equipment, where applicable.

SECTION 10. SAFETY GUIDELINES FOR PUBLIC UTILITY VEHICLES.

10.1. **SAFETY GUIDELINES FOR PUBLIC UTILITY VEHICLES:** All permitted public utility vehicles (PUVs), transport terminals and operators must follow the following set of rules:

- 10.1.1. Safety refers to guidelines that reduce contact, transmission and spread of the virus through the mandatory use of face masks and gloves for drivers, through disinfecting practices of vehicles, terminals, and even among passengers are also required.

Capacity and passenger load factors will be required for each mode of transportation to ensure that physical distancing is followed.

1. Public utility jeepneys (PUJs) should not exceed fifty percent (50%) or half of the vehicle's capacity, excluding driver and conductor.
2. Tricycles must not exceed one passenger in the sidecar, while back riding is not allowed.
3. The mode of PUV that will operate in each route will be guided by the number of passengers that will be transported.

4. Private cars and motorcycles will be allowed to operate strictly for the purpose of essential travels.
5. Private cars will only be allowed one (1) passenger to occupy the front passenger seat, while front – facing seats shall not exceed two (2) passengers per row.
6. Motorcycles are prohibited from having back ride passengers.
7. The use of bicycles and similar devices are also highly encouraged.

10.1. 2. Additional Measures include the following;

1. Physical distancing and limited passenger capacity as well as required sanitary measures shall be strictly observed.
2. TODAs will operate during the MGCQ on the basis of demand and number of passengers. The safety of passengers shall be of paramount consideration.
3. Passengers shall be allowed to disembark only at designated drop off points.
4. PUV operators, drivers and conductors shall secure a medical certificate from their respective MHOs.
5. The foregoing requirements shall be fully complied with prior to resumption of operations of PUVs.

10.1.3. For purposes of contact tracing;

1. Passenger manifest shall be taken at designated terminal prior to departure where the conductor or dispatcher can record pertinent information of the commuters who utilized the vehicles for contact tracing purposes.
2. To further enhance contact tracing passengers are required to take note of the plate number or body number of the PUV they rode, date and time they boarded and the route they took.
3. All PUVs shall display this reminder on contact tracing with the plate number/body number of the vehicle and contact number of operator prominently visible to all passengers.

10.2. Additional sanitary measures shall be enforced, such as:

- a. Wearing of face masks at all times.
- b. Use of thermal scanners in terminals.
- c. Availability of alcohol and sanitizers in PUVs.
- d. Disinfection of high – touch surfaces of vehicles.
- e. Establishment of disinfection facilities in public transport terminals.

10.3. The Maritime Sector shall adopt the following;

- 10.3.1. All disinfecting facilities, such as footbaths, handwashing stations with alcohol and/or soap, and sanitation tents will be established at all entrances of the terminals, ports, in ships and other passenger vessels.

10.3.2. Wearing of Personal Protective Equipment (PPEs) shall be mandatory. Upon entering ports, terminals and passenger vessels, all individuals shall undergo disinfection procedures.

10.3.3 To ensure cleanliness that will abate the spread of COVID – 19, thorough disinfection of ships, passenger vessels, ports, terminals and facilities, as well as various equipment, will be carried out and implemented routinely.

10.3.4. All passengers entering the ports shall be required to accomplish entry and health protocol forms for purposes of contract tracing.


10.3.5. SOCIAL DISTANCING. Measures to enforce actual physical distancing among passengers and personnel shall be strictly observed inside ports, ships and other passenger vessels at all times. Physical distancing shall also be strictly practiced in port facilities, particularly in areas for frontline services, such as passenger terminal buildings (PTB), port integrated clearing offices, among others.

10.3.6. PASSENGER CAPACITY. In accordance with the IATF and DOH protocols, passenger capacity in ships and other passenger vessels SHALL BE REDUCED TO FIFTY PERCENT (50%).

SECTION 11. GUIDELINES FOR INTERZONAL MOVEMENT.

1. The interzonal movement of persons between areas placed under GCQ and MGCQ for any purpose **OTHER THAN LEISURE** shall be permitted.
2. The movement of the following persons within and across areas placed under any form of community quarantine shall be permitted:
 - a. Health care Workers, government officials and government frontline personnel, workers in permitted establishments and persons providing essential goods and services and public utilities, essential skeleton workforce, who shall present pertinent documents upon inspection at Quarantine Control Points (QCPs).
 - i. Employee Identification (ID) Card
 - ii. Certificate of Employment
 - iii. Any document showing place of residence and address of employer
 - b. Those traveling for medical and humanitarian reasons, and persons transiting to the airport for travel abroad, who shall present applicable pertinent documents upon inspection at QCPs:
 - i. Valid Identification (ID) Card
 - ii. Medical Certificate
 - iii. Passport and Plane ticket with flight details
 - iv. Travel Pass or Clearance from LGU of Origin

v. Travel Pass or Clearance from LGU of Destination, if applicable

3. Movement of all types of cargoes by land, air or sea within and across the locality shall be unhampered. Provided, that only maximum of (5) personnel may operate cargo and delivery vehicles by land or sea, with or without load.
 - a. All cargoes (food and non-food) within, to and from Quezon Province shall not be delayed by reason of quarantine.
4. Workers in the logistics sector, such as cargo, trucking and port operations shall likewise be allowed to transit across the municipality.
5. Land, air, or sea travel by uniformed personnel and government officials and employees for official business, with the corresponding travel authority, especially those transporting medical supplies and laboratory specimens related to COVID-19, and other relief and humanitarian assistance shall be allowed.
6. OFWs, students enrolled abroad and participants accepted in exchange visitor programs, permanent residents of foreign jurisdictions, and stranded foreign nationals may leave for abroad through designated without any impediment.
7. Departing passengers may be accompanied by not more than one (1) person when traveling to any international port, who shall be allowed to return to his/ her point of origin.
8. Repatriated OFWs or returning non-OFWs who have been issued a DOH and/or LGU certificate of completion of fourteen (14) day facility based quarantine, or those who may be unhampered transit across zones *en route* to their final destination.
9. A Travel Clearance/ Authority shall be issued by the LGUs of destination, if applicable.

SECTION 12. GUIDELINES ON INTRAZONAL MOVEMENT (WITHIN QUEZON PROVINCE AND TO/FROM OTHER MGCQ AREAS.

1. Individuals traveling to from other provinces for non- work related purposes will be required to obtain Travel Pass or Travel Authority from appropriate government agency.
2. The movement of residents for any purpose across and within Quezon Province shall be permitted.
3. Insofar as tourism travel is concerned, the same may still be subject to regulations of the LGU concerned in observance of the foregoing guidelines and minimum public health standards.

SECTION 13. GUIDELINES FOR THE MANAGEMENT OF REPATRIATED OVERSEAS FILIPINO WORKERS (OFWS) AND RETURNING NON – OFWs.

Operational guidelines on the management of repatriated OFWs and returning non – OFWs shall be in accordance with the guidelines issued by the DILG, and the JTF CV Shield.

1. Repatriated OFWs must comply with approved quarantine protocols issued by the DOH – Bureau of Quarantine (BOQ).
2. All arriving non-OFWs shall be managed in accordance with the updated algorithm for the triage and management or repatriated OFWs from high risk or other jurisdictions issued by the Department of Health and the Bureau of Quarantine.
3. Repatriated OFWs or returning non – OFWs who have been issued a DOH or LGU certificate of completion for fourteen (14) day facility – based quarantine, those who may be required to undergo a mandatory fourteen day home quarantine, or those who are issued a travel authority upon testing negative for COVID – 19 whichever is earlier, shall be granted unhampered transit across zones n route to their final destination in the Philippines.
4. Travel Authority (TA) shall be issued by the JTF CV Shield, under the following protocol:
 - For inter – regional movement, TA issued by the Commander of JTF CV Shield.
 - For intraregional movement, TA issued by the Commander, Regional JTF CV Shield.
 - For movement between component cities and municipalities of the same province, TA issued by the Commander, Provincial JTF CV Shield.

SECTION 14. CLASSES.

1. Limited face – to – face or in – person classes may be conducted in HEIs provided there is strict compliance with minimum public health standards, consultation with local government units, and compliance with guidelines set by CHED.
2. Face – to – Face TVET training and competency assessment may be conducted at up to 50% training and assessment site capacity, provided compliance with minimum public health standards, TESDA Guidelines and consultation with LGU.
3. For K – 12 Basic Education, the Basic Education Learning Continuity Plan for the DepEd shall be adopted.

SECTION 15. SIGNIFICANT HEALTH MEASURES TO REDUCE TRANSMISSION OF COVID – 19 IN WORKPLACES:

1. All employers and workers shall:
 - a. Wear face masks at all times and remove the same only when eating/ drinking.
 - b. Employers must provide the appropriate masks for workers. Should cloth masks be used, the washable type shall be worn but additional filter materials such as tissue papers inside the masks must be added.
 - c. Clients shall accomplish health symptoms questionnaire and submit to the guard or designated safety officer prior to entry.
 - d. Have their temperature checked and recorded in the health system questionnaire.
 - e. Spray alcohol/sanitizers to both hands, and provide disinfectant foot baths at

the entrance if practicable.

2. For any personnel with temperature > 37.5C, even after a five – minute rest, or if their response in the questionnaire needs further evaluation by the clinic staff, the person shall be isolated in an area identified by the company and not be allowed to enter the premises. The isolation area should be well – ventilated and must be disinfected frequently.
3. Clinic staff assigned to assess the workers held in the isolation area shall be provided the appropriate medical grade PPEs by the establishments which shall include but not limited to face masks, goggles/face shield and/or gloves.
4. Employers may test workers for COVID – 19. Testing kits used and procured shall be the responsibility of the employer.

SECTION 16. DISINFECTION DAY IS MANDATORY. Schedule of disinfection in all establishments allowed to operate including all government offices shall be taken, recorded and monitored by the MIATF.

Section 17. Enforcement – This Municipal Ordinance shall be implemented and enforced by the Punong Barangays, Philippine National Police (PNP) and other government officials or authorities concerned. Punong Barangays may deputize the Barangay Tanods/BPATs and other force multipliers to enforce this Municipal Ordinance in their respective area of jurisdiction.

Section 18. Penalty Clause – any person who violates the provision of this Municipal Ordinance shall be penalized as follows:

- a. Failure to observe social/physical/safe distancing in public places:

- 1st Offense** – A fine of One Thousand Pesos (Php1,000.00) or one (1) hour community service/day for three (3) days.
- 2nd Offense** – A fine of One Thousand Five Hundred Pesos (Php1,500.00) or three (3) hours community service/day for five (5) days.
- 3rd Offense** – A fine of Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not less than fifteen (15) days, or both, at discretion of the court.

- b. Violation of mandatory wearing of face mask in public places:

- 1st Offense** – A fine of One Thousand Pesos (Php1,000.00) or one (1) hour community service/day for three (3) days.
- 2nd Offense** – A fine of One Thousand Five Hundred Pesos (Php1,500.00) or three (3) hours community service/day for five (5) days.
- 3rd Offense** – A fine of Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not less than fifteen (15) days, or both, at discretion of the court.

c. Violation of Curfew

- 1st Offense** - A fine of One Thousand Pesos (Php1,000.00) or one (1) hour community service/day for three (3) days.
- 2nd Offense** - A fine of One Thousand Five Hundred Pesos (Php1,500.00) or three (3) hours community service/day for five (5) days.
- 3rd Offense** - A fine of Two Thousand Five Hundred Pesos (Php2,500.00) or imprisonment of not less than fifteen (15) days, or both, at discretion of the court.

SECTION 19. SEPARABILITY CLAUSE. If any portion or provision of this Ordinance is declared void or unconstitutional, the remaining portions hereof shall not be affected thereby and shall remain in full force and effect.

SECTION 20. REPEALING CLAUSE. Executive Orders, rules and regulations or parts thereof, which are inconsistent or in conflict with the provisions of this Order, are hereby repealed or modified accordingly:
