I. DESCRIPTION

- A. Project Title **PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) (LGU COUNTERPART)**
- B. Project Location 20 Barangays of the Municipality of Polillo, Quezon
- C. Brief Summary of the Project It is to promote the family as a foundation of the nation, strengthen its solidarity and ensure total development. In support to this policy, the Pantawid Pamilyang Pilipino Program (4P's) has been developed as poverty reduction measure. The DSWD was tasked to lead the implementation of this program and the Municipality of Polillo has been identified as site for the implementation of the program. The LGU shall provide logistic counterpart as indicated in the Memorandum of Agreement (MOA). Two (2) DSWD Municipal Links and two (2) LGU Links shall be responsible in the implementation of this program in coordination with Municipal Social Welfare and Development Office.
- D. Project Goals & Objectives The DSWD advocates for the implementation of Pantawid Pamilyang Pilipino Program (4P's) for extremely poor households that aims to build human capital through accessing health nutrition and education services of children 0-18 years old.
- 1) Regular monitoring visits and Facilitation of Family Development Session at 20 barangays should be done.
 - 2) Regular conduct of consultation meeting with the implementer. Discussion and agreements should be properly documented to keep track of the implementation updates.
 - 3) All Pantawid Pamilyang Pilipino Program implementers are utilization of the funds approved for the projects and effective delivering of activities to basically achieve the purpose of the project with consideration of the project duration.
 - 4) Prepare project proposals and other budgetary requirements at the Municipal level.
 - 5) Regular conduct of Gender Sensitivity Training for Male Spouses for Pantawid Beneficiaries.

III. PROJECT SUSTAINABILITY

THE MUNICIPAL GOVERNMENT SHALL;

- a) Ensure that education and health services required by the program are available and adequate for beneficiaries within the duration of the program.
- b) Work for the accreditation of its Rural Health Units to Philhealth within the first year of program implementation. Provide for the corresponding LGU counterpart funds for enrollment of household beneficiaries to Philhealth for the entire duration of the program.
- c) Designate counterpart LGU Links to assist the DSWD hired Municipal Links in the implementation of all Pantawid Pamilya activities in the city/municipality.
- d) Provide office supplies, equipment and other paraphernalia for the period of program implementation.
- e) Conduct regular monitoring and provide technical assistance to Municipal Link and mother leaders to ensure effective program implementation.
