





RESOLUTION NO. 001-2021

A RESOLUTION AUTHORIZING MAYOR CRISTINA E. BOSQUE TO RENEW AND SIGN THE CONTRACT OF LEASE BETWEEN THE LOCAL GOVERNMENT UNIT OF POLILLO AND MR. JOSE E. ANG, OWNER OF THE HOUSE, RELATIVE TO MONTHLY RENTAL AGREEMENT OF BAHAY TULUYAN, TO BE USED AS TRANSIENT HOUSE OF POLILLIANS ATTENDING IMPORTANT MATTERS IN LUCENA CITY, GIVING PRIORITY HOWEVER TO RELATIVES ATTENDING TO THE PATIENTS WHO ARE NOT CAPABLE FINANCIALLY OF PAYING RENTALS

WHEREAS, on January 7, 2021, the Office of the Sangguniang Bayan had received a letter from the Office of the Municipal Mayor, endorsing a draft of Contract of Lease authorizing the Local Chief Executive to renew and sign the Contract of Lease relative to monthly rental agreement of Bahay Tuluyan in Lucena City;

WHEREAS, there is a continuing flow of Polillians going to Lucena City attending to important matters, particularly those accompanying patients who cannot afford to stay in hotels or rent a temporary shelter in the area;

WHEREAS, one of the priority programs of this municipality is to provide services to its constituents whether they are in Polillo or in other locality;

WHEREAS, to provide such assistance and services, the Municipality of Polillo through its Local Chief Executive needs to rent a transient house;

WHEREAS, as specified in the contract, the lease agreement shall be valid for a period of Twelve (12) Months beginning on January 1, 2020 to December 31, 2020 at a rate of Fifteen Thousand Pesos (Php15,000.00) per month;

WHEREAS, there is a need to authorize the Local Chief Executive to sign the contract of lease between the Local Government Unit of Polillo and Mr. Jose E. Ang, for the continuous implementation of the program;

NOW THEREFORE, on unanimous motion, be it:

RESOLVED, as it is hereby resolved, to authorize Mayor Cristina E. Bosque to renew and sign the Contract of Lease between the Local Government Unit of Polillo and Mr. Jose E. Ang, Owner of the House, relative to Monthly Rental Agreement of Bahay Tuluyan, to be used as Transient House of Polillians attending important matters in Lucena City, giving priority however to relatives attending to the patients who are not capable financially of paying rentals;


RESOLVED FURTHER, to send the Offices of the Municipal Mayor, Mr. Jose E. Ang of Lucena City and all concerned offices copies of this Resolution for information, record and appropriate action.
