A RESOLUTION APPROVING THE PROJECT ENTITLED: CONSTRUCTION OF ROAD WITH SLOPE PROTECTION AT BRGY. ATULAYAN, POLILLO, QUEZON, AMOUNTING TO TWO MILLION AND TWO HUNDRED THOUSAND PESOS (PHP2,200,000.00) TO BE FUNDED FROM THE ADDITIONAL 20% DEVELOPMENT FUND OF 2021 WHICH WAS APPROVED BY MUNICIPAL DEVELOPMENT COUNCIL (MDC) THROUGH RESOLUTION NO. 01-2021
