A RESOLUTION ADOPTING THE REVISED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN FOR FY 2021 WHICH WAS APPROVED BY MUNICIPAL DEVELOPMENT COUNCIL (MDC) THROUGH RESOLUTION NO. 2A-2021

WHEREAS, as mandated by Republic Act 7160, the Municipal Development Council (MDC) is tasked to study, formulate and adopt Development Plans, Programs and Activities for every locality, to uplift the social, economic and political well-being of its community, addressing concerns specifically on poverty reduction, unemployment and propel economic growth;

WHEREAS, MDC was convened to discuss the Revision of the Local Disaster Risk Reduction and Management Plan for FY 2021 for there is an additional fund for appropriation from the actual Internal Revenue Allotment (IRA) for the Local Government Unit of Polillo, along with other subsidies and/or assistance from the National Government Agencies;

WHEREAS, the Municipal Development Council (MDC) through its Resolution No. 2A-2021, approves the Revised Local Disaster Risk Reduction and Management Plan for FY 2021 of the Municipality of Polillo, and recommends adoption by the Sangguniang Bayan;
