A RESOLUTION APPROVING THE PROPOSED PROJECT PROFILE FOR KALAHI-CIDSS (NATIONAL COMMUNITY DRIVEN DEVELOPMENT PROJECTS (KC-NCDDP) WITH FUND REQUIREMENT OF FOUR MILLION TWO HUNDRED THOUSAND PESOS (PHP4,200,000.00) FROM THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICER

WHEREAS, the Sangguniang Bayan had enacted Appropriation Ordinance No. 007-2020 on December 14, 2020;

WHEREAS, Section 17 of the above-mentioned Appropriation Ordinance stipulates that: Lump-sum Appropriations for Programs/ Projects/Activities - The lump-sum appropriations for Programs/Projects/Activities in different offices must have a detailed list of plans or activities or in lieu is a Project Profile/Activity Design/Program of Works which should be prepared and submitted to the Sangguniang Bayan for approval;

RESOLVED, as it is hereby **RESOLVED**, to approve the Proposed Project Profile for KALAHI-CIDSS (National Community Driven Development Projects (KC-NCDDP) with fund requirement of Four Million Two Hundred Thousand Pesos (Php4,200,000.00) from the Office of the Municipal Social Welfare and Development Officer;

RESOLVED FURTHER, to subject the said Proposed Project Profile under the following provisions:

- 1. Consistent with Section 17 of SB Appropriation Ordinance No. 007-2020, the Lump-sum Appropriations for Programs/Projects/ Activities. The lump-sum appropriations for Programs/Projects/ Activities in different offices must have a detailed list of plans or activities or in lieu is a Project Profile/Activity Design/Program of Works which should be prepared and submitted to the Sangguniang Bayan for approval. Any major changes in the said Project Profile/Activity Design/Program of Works such as additional line items for expenses will also require an approved Sangguniang Bayan Resolution. Minor changes which can be considered as augmentation between line items of expenses, and other petty changes need not be returned to the Sangguniang Bayan for another approval.
- 2. Job Appointment or contract of services of personnel or staff (job orders) whose wages or honoraria are charged against a particular project fund and their corresponding job functions/tasks/responsibilities shall be made an integral attachment of each project profile.
- By practically applying the cost-benefit analysis principle, periodic accomplishment or status reports with necessary recommendations per project are deemed important to determine the level or extent of development made against the fund allocated.
- 4. Each department head should make specific categorization based on functions, tasks and skills of job order personnel with a motivational intent of increasing to the appropriate level the wages/honoraria of said personnel.
- 5. Section 12 of SB Appropriation Ordinance No. 007-2020 Procurement of Infrastructure Projects, Goods and Services and Consulting Services. Procurement should strictly adhere to the provisions of RA 9184 and its revised Implementing Rules and Regulations (IRR) and all other issuances issued by the Government Procurement Policy Board and other concerned governing bodies.
