RESOLUTION NO. 023-2021

A RESOLUTION AUTHORIZING THE MUNICIPAL TREASURER, CARMELITA C. MARASIGAN TO COLLECT THE TOURISM ENVIRONMENTAL FEE TO ALPHALAND BALESIN ISLAND CLUB, INC. (ABICI), RELATIVE TO THE IMPLEMENTATION OF MUNICIPAL ORDINANCE NO. 128-2018, ENTITLED: AN ORDINANCE PRESCRIBING TOURISM ENVIRONMENTAL FEE AND IMPOSING PENALTIES FOR VIOLATION THEREOF IN THE MUNICIPALITY OF POLILLO, QUEZON

WHEREAS, referred to the Committee on Tourism for its thorough study and recommendation to the Sangguniang Bayan is the letter from the Office of the Municipal Treasurer requesting to authorize the Municipal Treasurer, Carmelita C. Marasigan to collect Tourism Environmental Fee to Alphaland Balesin Island Club, Inc. (ABICI), relative to the implementation of Municipal Ordinance No. 128-2018, entitled: An Ordinance prescribing Tourism Environmental Fee and imposing penalties for violation thereof in the Municipality of Polillo, Quezon;

WHEREAS, said request of the above-mentioned Office was based on a letter from Alphaland Balesin Island Club, Inc. (ABICI), through Michael Angelo Patrick M. Asperin, Chief Executive Officer, which reads as follows:

This is to confirm that beginning March 1, 2021, Alphaland Balesin Island Club, Inc. (the "Club") agrees to collect, on behalf of the Municipality of Polillo, environmental fee (the "Fee") in the amount of Two Hundred & 00/100 in Philippine currency (Php200.00) for each guest of the Club. It is understood that no Fee shall be collected from members of the Club, who are stakeholders thereof.

The Club further agrees to regularly remit to the Municipal Treasurer of Polillo all collections made hereunder every month and provide a copy of guest list which shall be the basis for the

environmental fee collection. Any remittance made by cheque shall be made payable to: "The Municipal Treasurer, Polillo, Quezon".
