Appropriating funds therefore and for other purposes or the Solo Parents Welfare Act of 2000 declares that is the policy state to promote the family as the foundation of the nation, strengthen its solidarity and ensure its total development.

Republic Act 8972 was enacted to provide a comprehensive program of services for SOLO PARENTS and their CHILDREN. This LAW covers fathers or mothers who raise their children by themselves, either because of the death of spouse, abandonment, separation, or even those who have children as a result of rape. Part of the implementation of the laws is to develop plans policies, programs, measures and mechanisms to address inequality in the economic political, social and cultural life of women and men.
