Twenty-Five (25) SC Association within 19 Barangay and Six (6) Puroks at Brgy. Poblacion, Polillo, Quezon.

The Office of the Mayor, thru OFFICE OF THE SENIOR CITIZENS AFFAIRS with personnel composed of one (1) OSCA – Head with Honorarium as compensation, two (2) OSCA Project Aide as LGU Job Order and (1) S.C. Center Worker wages is under subsidy/Aide. The OSCA under the Office of the Municipal Mayor, will be managed by the OSCA-Head and Staff thru the supervision of the MSWDO, with the task to promote Social Justice and services, for the Welfare of Older Persons (OP) Senior Citizens (SC), bedridden, we support the priority benefits and privileges of our S.C. pursuant with the principles of the following:

- > RA 9994 The Expanded Senior Citizens Act of 2010;
- RA 7876 The S.C. Center Act of the Philippines which provide comprehensive Health Care and Wellness Program;
- > RA 10606 The National Health Insurance Act of 2013 fir the Mandatory Health coverage of S.C.; and
- The Philippines Plan of Action for S.C. 2012-2016, the promotions of active ageing thru Social Protection for the Rights, Welfare and Empowerment of the Elderly.

- To recognize the rights of S.C. to take their proper place in society and make them a concern of the family, community and the government;

II. PROJECT MANAGEMENT

The Office of the Senior Citizens Affairs (OSCA) thru the management of the OSCA-Head and Staff in cooperation with the SC Federation President, under the office of the Municipal Mayor, with the supervision of the MSWDO are the responsible personnel who will give full support and services for the improvement of the Elderly who posses many needs especially in all matters relating for their Health Care, social services and giving priority for the needs of the under privileged, sick and disabled indigent senior citizens. These OSCA Staff will see to it that all SC at the age of 60 years old must be issued their National OSCA ID Card and be a member for the m=Mandatory Philhealth coverage and that all indigent SC shall be entitled for a monthly stipend of P500.00 under the Social Pension Program of the Government.

III. PROJECT SUSTAINABILITY

The Office of the Senior Citizens Affairs (OSCA) under the office of the Municipal Mayor thru the supervision of the MSWDO, give support to the improvement of the total well-being of the elderly and their full participation in society considering that the Older Person/Senior Citizens are integral part of our society. The gender focus of the government as well as by every Local Chief Executive is for the welfare of these Older Persons especially those with disability and bedridden. To five full support and services for the improvement of elderly who posses many needs, the government introduced different strategies to address these needs, loke the creation of the office of the Senior Citizens Affairs (OSCA) for the implementation of the benefits and special privileges of these Older Persons, pursuant with the constitutional principles of the RA 9994 the expanded SC Act of 2010 and RA 7876 for establishment of the S.C. Center in all cities and municipalities for the Protective Services Program and comprehensive approached towards Health Development giving priority to Elderly among others.
