Twenty (20) Barangays of the Municipality of Polillo, Quezon.

The office of the Municipal Mayor thru the MSWDO with the assistance of the Focal Person, supports and recognizes the Persons with Disability (PWD) as one of the sector of our society; hence, they should be treated with proper care and attention as well as to provide protection for the poor, sick and abandoned PWD in order to pursue potentials and provide opportunities to restore their social and participation functioning community affairs. The program for persons with disabilities that were devolved to the local government units, Republic Act 9942, amended by the RA 7277 the MAGNA CARTA for PWD and Batas Pambansa Blg, 344 all provided the need for a strong agency to monitor services for disabled persons.

- To conduct information, education and advocacy campaigns on disability issues/concerns, rights and privileges.
- 2) To empower PWDs to gradually become partners in nation building.
- 3) To consult and establish linkages with National Council for the Welfare of Disabled Persons, DSWD, PSWDO and other concerned agencies for possible implementation of programs and projects applicable in the municipality.
- 4) To advocate for the creation of local committee for the welfare of persons with disabilities.
- 5) To support in strengthening of PWD Municipal Federation.
- 6) To provide diapers for PWD bed bounded and Foods & Groceries for the selected indigent PWD members.
- 7) Continues monitoring for PWD livelihood Program
- 8) To conduct home visitation and monitoring for PWD Indigent and Bedridden

- 9) To give support of financial assistance for Persons with Disability Indigent who are alone / Orphan
- 10) To provide the individual of Persons with Disability financial assistance for the certain exclusive needs.

The National agencies and Local government units may enter into joint ventures with organizations or associations of PWDs to explore livelihood opportunities and other undertakings that shall enhance the health, physical fitness and the economic and social well-being of Persons with Disabilities (PWDs).

III. PROJECT SUSTAINABILITY

The Local Government Unit (LGU) with the management of the focal person thru the supervision of the MSWDO under the office of the Municipal Mayor support and recognizes the Persons with Disability (PWD) who belong the sector of our society; hence, they should be treated with proper care and attention, among others for persons with disabilities will enhance their capability to attain a more meaningful, productive and satisfying way of life and ultimately become self – reliant and contributing members of society. The Republic Act 9442, Amended by Republic Act 7277 – An Act Providing for the Rehabilitation, Self – Development & Self – Reliance of Disabled Persons and their Integration into the Mainstream of Society and for other Purposes also known as the "Magna Carta for Disabled Persons", declaring the rights and privileges of persons with disabilities to equal opportunities to empowerment, educational health, auxiliary social services telecommunications, accessibility and political and civil exercises.

Batas Pambansa Blg. 344 – An Act to Enhance the Mobility of Disabled Persons by Requiring certain buildings, institutions, establishment and public utilities to install facilities and other devices. Further, Republic Act No. 10070

was approved on April 6, 2010 to ensure that policies, program and services for persons with disabilities are implemented to establish of Person with Disabilities Affairs Office (PDAO).
