
INVITATION TO BID FOR:

**CONSTRUCTION OF BRIDGE FROM WOODEN TO CONCRETE-
SO.MALO MALAKI, BRGY. PAMATDAN, POLILLO, QUEZON**

1. The Municipality of Polillo, through the **20% Development Fund 2021** intends to apply the sum of **Nine Million Eight Hundred Eighty Five Thousand Seven Hundred Thirty Three Pesos & 28/100 Only (₱ 9,885,733.28)** being the Approved Budget for the Contract (ABC) to payments under the contract for **CONSTRUCTION OF BRIDGE FROM WOODEN TO CONCRETE-
SO.MALO MALAKI, BRGY. PAMATDAN, POLILLO, QUEZON.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Polillo now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred Eighty (180) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.
4. Interested bidders may obtain further information from **Municipality of Polillo** and inspect the Bidding Documents at the address given below from, **8:00AM to 5:00PM (Monday to Friday)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 5-26, 2021** (before 2:30PM) from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **₱ 10,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person, by facsimile, or through electronic means.
6. The Municipality of Polillo will hold a Pre-Bid Conference on **May 12, 2021, 2:30 PM** at **BAC Unit Office (former MPDC office), 2nd Floor Municipal Building-Annex, Mabini St., Brgy. Poblacion, Polillo, Quezon**, and/or through videoconferencing/webcasting via messenger, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below on or before **May 26, 2021, 2:30pm** at the address below on or before **May 26, 2021, 2:30PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on **May 26, 2021, 2:30PM** at the given address below and/or through messenger. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Municipality of Polillo** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder of bidders.
