REQUEST FOR EXPRESSION OF INTEREST FOR
CONSULTATION SERVICES FOR-CONSTRUCTION OF ATULAYAN-BISLIAN-
PAMATDAN FMR PROJECT OF LGU POLILLO, QUEZON

1. The Municipality of Polillo, through the Supplemental Budget 2021 by the Sangguniang Bayan intends to apply the sum of **Four Hundred Fifty Thousand Pesos Only (₱ 450,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for CONSULTATION SERVICES FOR-CONSTRUCTION OF ATULAYAN-BISLIAN-PAMATDAN FMR PROJECT OF LGU POLILLO, QUEZON. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Polillo now calls for the submission of eligibility documents for Farm to Market Road Field Inspections, Engineering, Geodetic and Land Survey. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before July 7, 2021 at the address given below. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. Interested bidders may obtain further information from Municipality of Polillo and inspect the Bidding Documents at the address given below during Monday to Friday, 8:00 AM to 5:00PM.
4. A complete set of Bidding Documents may be acquired by interested Bidders on **July 1-14, 2021** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos Only (₱ 1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person, by facsimile, or through electronic means.
5. The date and time for opening of bids is July 14, 2021, 2:30pm at BAC Unit Office (former MPDC office), 2nd Floor Municipal Building-Annex, Mabini St., Brgy. Poblacion, Polillo, Quezon.
6. The opening of Financial Proposals shall be on July 15, 2021, 2:30pm at BAC Unit Office (former MPDC office), 2nd Floor Municipal Building-Annex, Mabini St., Brgy. Poblacion, Polillo, Quezon.
7. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The shortlist shall consist of 3 prospective bidders who will be entitled to submit bids.
8. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships or organizations with at least sixty percent (60%) interest outstanding capital stock belonging to citizens of the Philippines.
9. The Procuring Entity shall evaluate bids using the Quality-Cost Evaluation/Selection (QCBE/QCBS) procedure. Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
10. The contract shall be completed within sixty (60) calendar days.
11. The Municipality of Polillo reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder of bidders.
