- 2. The Municipality of Polillo now invites bids for the above Procurement Project. Completion of the Works is required Ninety (90) Calendar Days. A complete set of Bidding Documents may be acquired by interested Bidders on October 7-14, 2024 (before 2:30PM) from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P 500.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person, by facsimile, or through electronic means.
- 6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below on or October 14, 2024, 2:30pm. at the address below. Late bids shall not be accepted.
- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clausel6.
- 8. Bid opening shall be on October 14, 2024, 2:30PM at the given address below and/or through messenger. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
